



EUAC Supporting Membership conditions:

As a result of mutually beneficial interest from the commercial sector a membership category has been created specifically for supporting members.

EUAC supporting members can be:

Anybody or commercial enterprise involved directly or peripherally in the aquarium world that is able to support the activities of EUAC, commercially or otherwise.

The benefits available to **Full Supporting Members** are:

1. Free access to the EUAC member's list
2. Entitlement to present a poster and publicity information during EUAC conferences
3. The right to make use of the EUAC logo (registered) in publicity in association with a statement that you are supporting member of the EUAC.
4. The possibility to install a publicity booth at EUAC conferences free of charge on condition that the hosting aquarium/institute is providing a commercial /technical exhibition
5. The right to present a paper (oral presentation) during the EUAC conference upon request or on invitation on condition that the conference program permits
6. In addition the EUAC website gives the opportunity for supporting members to provide links to their own website as well as privileged access to technical articles, co-operative program reports and professional press.
7. EUAC has limited the number of Full Supporting Members to a total of 20 members in order to keep trade show room size requirements at conferences at a reasonable and practical level. This membership category is hence subject of availability.

A sub category for smaller companies qualifying as **Consultant Supporting Members** (generally for smaller companies with less than 5 employees) will have access to a reduced range of benefits which will include items 1, 2, and 5 only from the previous list. They will also have the right to state that they are a Consultant Supporting Member of the EUAC but will have no rights to use of the EUAC logo.

Fees

The current fee for Full Supporting Members is 2,350 Euros per annum.

The current fee for Consultant Supporting Members is 500 Euros per annum.

Begin and end of membership

The membership starts with returning the signed application below and acceptance by the EUAC Committee with effect usually of the next 1st of January (exemptions can be discussed). The membership is a continuing membership and will be renewed automatically for the next year. Termination of memberships can be made until the 31st of October with effect of year's end in writing by email to supportmembership@euac.com (tbc). Annual invoices will be sent out at the beginning of each year for the actual year. EUAC deserves the right to cancel the membership if the member is one year behind with membership fee payments.

The EUAC conservation commitment

The money EUAC receives from Supporting Members will primarily be used to support in-situ and/or ex-situ conservation programs as proposed by member institutions and after screening by the EUAC Executive Committee and secondarily to support covering annual conference costs as well as EUAC administrative costs.

EUAC sincerely thanks those companies that support us in our conservation activities as the boundaries of our aquatic environment are constantly increasing. Our conservation activities, together with the activities of other organizations can contribute to safeguard biodiversity and planet Earth.
